Edmondson Avenue Improvements & Beautification

During my tenor on the Academy Heights board over the past 10 years, a constant topic in varying ways has always been Edmondson Avenue. Going well beyond those 10 years, many residents near Edmondson started to deal with the unfortunate issues around the antiquated sewer system. For many years those neighbors had to deal with some long-term hardships and extensive property damage from flooding due to the undersized sewage system. The County's Sewage Relief Program eventually addressed those issues and was completed in 2020. This project required much disruption to Edmondson. We also have had to

deal with occasional water main breaks over the years due to the aging water system. Then the BGE Gas Project began in 2018 that entailed new gas lines to each household. That project took a break in our area for a few years and picked up again this year along Edmondson. This has caused ongoing work along the roadway as BGE addresses households along the road. There has also been the constant issue of speeding along Edmondson, between Academy and Harlem, along with reckless driving. This has been the cause of some serious accidents and damage to resident's vehicles. Also, the ongoing digging and patching along Edmondson has destroyed the designated painted crosswalks. These crosswalks are essential for our bus stops and walkability to neighboring communities.

The Board has regularly attempted to address all of these issues at varying degrees and times over the past decade. This has included board members taking responsibilities of reaching out to our County and State officials, and dealing with multiple agencies and individuals over the years. I want to thank our board members (past & present) for their dedication, specifically Chris Burke, Doug Kampe and Rita Hall.

next year. County Representatives from Bureau of Highways and Traffic Engineering attended last month's community meeting to discuss the plans that are in place for improving Edmondson Avenue alongside the Academy Heights community. The County revealed the details of the plans that include repaving, curbing, center islands, landscaping, improved crosswalks, signage and a traffic circle at Academy & Edmondson. Parking will be removed from the south side and bike lanes added to both sides. The plan is currently concluding a pedestrian walkability and safety study that will result in final updates to the plans. Those results will then be shared with the association for feedback. Full construction of the final plans cannot move forward until BGE has completed their gas line work, tentatively late 2025. However, Traffic will move forward with work on curbs, ramps and drainage. Final construction will take abut 4 weeks. We will keep the community aware of any updates.

ALLEYWAY PARKING

Due to the ongoing struggles of attempting to locate an open parking space, residents may find it necessary to park in the alleyways. In doing so, residents must be aware of the County laws and the responsibility that is entailed. Baltimore County law states that "A person may not park, stop, or leave unattended a vehicle in any alley leaving less than 12 feet of clearance parallel to the vehicle." Depending on how a vehicle is parked, it may be very difficult to leave 12 passable feet in some sections of our alleys. Most of our alleys are only about 16 ft. wide. Trash and work trucks must have clearance, and emergency vehicles should be able to pass at all times. Residents are further reminded that they should report any vehicles blocking an alley to the BCPD at 410-887-2222. Also, there has been a recent increase of parked vehicles blocking our ADA corner curb ramps. Police randomly patrolling the neighborhood will ticket these vehicles immediately.

fyi - As a new resident of Maryland, you must title your vehicle within 60 days of moving to Maryland. If you delay beyond 60 days, you will not be eligible for a tax credit for any titling tax paid in another state, and you will be subject to a citation fine for an out of state registration.
